Terms of Reference (TORs)

- i) To formulate an effective mechanism in consultation with all relevant department to effective implementation of the ratified conventions;
- ii) To develop identical protocols for implementation which can work as effective tools for Provincial Government and its Departments to documents the progress regularly;
- iii) To help and guide the relevant departments for formulation of templates which can provide for reporting in prescribed and tabulated formats and generation of reports on compliance, in line with the international best practices;
- iv) To coordinate with the concerned Provincial Departments and authorities to collect and compile data for the regular treaty reporting and for the Score Card reporting;
- v) To form a liaison-mechanism with the relevant Federal Ministries for reporting on and monitoring of the Conventions and Score Card;
- vi) To nominate Focal Person (well versed in the matter of treaties) by all member departments of TIC;
- vii) To collect periodical reports from relevant Provincial departments for dissemination to all stakeholders;
- viii) Member departments to establish/setup separate sections on permanent basis for smooth functioning including data collecting, compiling and sharing
- ix) To formulate mechanism, to collect updated data / reports from relevant departments for sharing to all stakeholders on monthly basis;
- x) Human Rights Department shall provide support to member departments with regard to preparation of report(s) relating to treaties.
- xi) TIC will hold meetings on quarterly basis to review the progress on GSP+, National Action Plan on Human Rights (NAHR) and National Plan of Action on Business and Human Rights (NAP&BHR).
